# CENTRAL RANGES PIPELINE GAS NETWORK NOTIFICATION OF ANNUAL TARIFF INCREASE

## (For Reference Tariff Effective 1 July 2015 to 30 June 2016)

In accordance with section 3.2, 3.3, 3.4 and 3.4A of the Central Ranges Pipeline (CRP) Gas Network approved Access Arrangement as amended, please be advised that Central Ranges Pipeline Pty Limited intends to vary the CRP Gas Network 2014/15 Reference Tariff as per the tariff escalation method in 3.3:

$$RT_n = RT_{n-1} \times \left(\frac{CPI_{n-1}}{CPI_{n-2}}\right)$$

#### Where:

**CPI** means the Consumer Price Index (All Groups - Weighted Average Eight Capital Cities) published quarterly by the Australian Statistician;

CPI<sub>n-1</sub> means the value of the average of the CPIs for the four quarters to December in Year<sub>n-1</sub>;

CPI<sub>n-2</sub> means the value of the average of the CPIs for the four quarters to December quarter in Year<sub>n-2</sub>;

As required by the Access Arrangement, the CPI figures used in this correspondence to calculate the average of the CPI for the four quarters to December 2013 and December 2014 are the CPI (All Groups – Weighted Average Eight Capital Cities) as published by the Australian Bureau of Statistics:

CPI Calculation	March	June	September	December	Average
CPI <sub>n-2</sub>	102.40	102.80	104.00	104.80	103.50
CPI <sub>n-1</sub>	105.40	105.90	106.40	106.60	106.075

Consequently the CPI escalator is (106.075 / 103.50) 1.024879.

This escalator has been applied to the CRP Gas Network Tariffs for 2014/2015 as shown below:
