

## **ElectraNet Mid North South Australia REZ Expansion Stage 1a - Early Works Contingent Project Submission Objection**

FROM THE PERSPECTIVE OF AUSTRALIAN SOVEREIGNTY AND LONG SUFFERING ELECTRICITY CONSUMERS, WE ABSOLUTELY REJECT AND CONDEMN ELECTRANET'S MID NORTH SA REZ EXPANSION STAGE 1A – EARLY WORKS.

On 28 March 2025, ElectraNet—a company 46.56% owned and controlled by our most hostile enemy, the Chinese Communist Party (CCP) through the State Grid Corporation of China—lodged an outrageous application to extract even more money from Australians. This time, the excuse is to fund "early works" for the Mid North South Australia Renewable Energy Zone (REZ) Expansion Stage 1a.

Clearly, this project is irrational, illogical, unnecessary, treacherous, and utterly against the best interests of the Australian people and the Greater Good.

It is the latest step in a long series of deceptions, policy failures, and foreign entrenchments that have systematically destroyed our once world-class electricity system—while sending bills skyrocketing, plunging reliability, and leaving us increasingly subject to Blackouts and Energy Poverty - due to the collapsing RenewaBull Grid experiment that's shamefully reliant on unethical, CCP Slave Labour Supply Chains.

ElectraNet's 28 March application, made under clause 6A.8.2 of the National Electricity Rules (NER), seeks to fund early activities like stakeholder engagement, land acquisition, project development and procurement.

However, this is just more bureaucracy, propaganda, and profiteering, all aimed at propping up the pathetically intermittent, weather-dependent failures of so-called "renewables" and the collapsed fantasy of hydrogen power.

This project, we are told, was identified in AEMO's 2024 Integrated System Plan (ISP)—an ISP which is not fit for purpose, not independent, and thoroughly discredited. It is an ideologically corrupted roadmap serving global green financiers and CCP-linked utilities—not the Australian people.

The claimed need for this REZ expansion has been shredded by a plethora of honest experts and collapses under scrutiny:

Supporting new 'renewables' north of Adelaide is a farcical, astronomical rip-off as these generators barely function during peak demand.  
Meeting growing industrial load in the Upper Spencer Gulf? Hardly, when industry is fleeing South Australia because of high energy costs.

Alleviating 'renewable' congestion? That's a crisis created by bad policy, not a justification for more of it!

Behind this energy shambles is the AER, the so-called Regulator, promising to "review the prudence and efficiency" of the application, as this is the usual hollow promise.

The AER has become a captured, complicit enabler of failed megaprojects like Project Energy Connect, VNI West, HumeLink, and Snowy 2.0.

It has never defended consumers.

It exists to rubber-stamp predatory, Fake Green RenewaBull, vested interest chaos, not prevent it!

This is not about delivering secure, affordable electricity.

This is about delivering profits and strategic advantage to the CCP, using our public funds, our land, and our Electricity Grid.

The Net Zero Australia Report estimates the renewables-only path will cost up to \$9 trillion—or \$850,000 per household. And still, NO Reliability. NO Security. NO Sovereignty.

Australia immediately needs reliable, affordable, dispatchable, sovereign, superior power - High-Efficiency, Low-Emissions (HELE) Coal power and an Australian-developed Nuclear power future as well.

**Immediate Moratorium on all REZ-related projects and ISP mandates is essential.**
