#### Re: Victorian Transmission System - 2026 Reference tariff adjustment notification

Pursuant to section 4.6 of the Access Arrangement in place for the Victorian Transmission System (VTS), APA VTS Australia (Operations) P/L (APA VTS) must make an initial notification to the Australian Energy Regulator (AER) of tariff adjustments to occur on 1 January 2026 at least 50 Business Days before the date of implementation of those adjustments.

APA VTS submitted an initial tariff adjustment notification on 17 October 2025 in satisfaction of this requirement. That initial tariff adjustment notification had been prepared prior to final winter demand figures coming available from the Australian Energy Market Operator, and Consumer Price Index information from the Australian Bureau of Statistics, being released. APA VTS has updated the modelling now those figures are available.

**Attachment A** to this letter sets out initial reference tariffs calculated in accordance with the prevailing access arrangement. These tariffs are presented in tables that correspond to those in the access arrangement.
