Overview

On 14 May 2025, the Australian Energy Regulator (**AER**) made its final determination for the Jemena Gas Networks (NSW) Ltd (**JGN**) access arrangement (**2025-30 AA**), to apply for the period from 1 July 2025 to 30 June 2030.¹ The 2025-30 AA is available at <http://www.aer.gov.au/> or <http://www.jemena.com.au>.

The 2025-30 AA describes the reference services that JGN offers, sets out the initial reference tariffs that apply to those services from 1 July 2025 and includes an annual tariff mechanism, effective 1 July each year of the 2025-30 AA period.

Reference tariffs are subject to variation annually in accordance with Section 3 of the 2025-30 AA (Reference Tariffs and Tariff Variation Mechanism). The 2026-27 reference tariffs to apply from 1 July 2026 have been calculated consistent with the 2025-30 AA. The tariffs are expressed in 2026-27 dollars and exclude GST. Annual variations are subject to approval by the AER.

Terms not defined in this document will be defined terms in JGN's 2025-30 AA. This document should be read in conjunction with JGN's 2025-30 AA, 2025-30 Reference Service Agreement and Tariff Assignment Policy.
