

## STATEMENT OF REASONS

## Envestra's Queensland Gas Distribution System: Notification of Annual Tariff Variation for 2014–15

The Australian Energy Regulator has approved annual tariff variations for Envestra's Queensland Gas Distribution System in accordance with clause 4.3 of the relevant access arrangement.

The reason for approving the proposed tariff variation is that:

- We are satisfied that Envestra has correctly applied the approved variation method to calculate the reference tariffs in accordance with clause 4.4 of the access arrangement for Envestra's Queensland Gas Distribution System. The approved method for transportation services consists of an escalation formula applied to a weighted average tariff basket of reference services (excluding metering and additional services). The escalation formula is the change in quarterly CPI on a year on year basis to March multiplied by an approved X factor. Tariffs for metering and additional services are escalated by the change in quarterly CPI on a year on year basis to March.
- The AER is satisfied that Envestra has correctly applied the approved method to calculate the carbon pass through amount in accordance with the AER's Decision for *Envestra Limited—cost pass-through event Application for the Queensland Gas Distribution System* published in 2012. The approved 2014–15 pass through amount is \$1.645 million. This resulted in daily fixed charges of \$0.0486 for Tariff R and Tariff C customers and an additional increase in monthly charges of \$1.50 for Tariff D customers.
