## Central Ranges Pipeline Access Arrangement: Reference Tariff Variation effective 1 July 2018

Central Ranges Pipeline Pty Ltd may, in accordance with clause 3.2 of the Access Arrangement approved by the Australian Competition and Consumer Commission in 2005, vary the reference tariffs of the Central Ranges Pipeline.

This letter notifies the Australian Energy Regulator of the varied reference tariffs which are to have effect from 1 July 2018 to 30 June 2019. This letter applies an estimate of the Mar 2018 CPI.

Pursuant to clause 3.3 of the Access Arrangement, the reference tariffs are to be varied using the following formula:

$$RT_n = RT_{n-1} \times \frac{CPI_{n-1}}{CPI_{n-2}}$$

where:

RT<sub>n</sub> is the reference tariff for year n;

n is the year ending 30 June in which the adjusted Reference Tariff is to be applied;

 $RT_{n-1}$  is the reference tariff for the year n-1;

 $CPl_{n-1}$  is the Consumer Price Index, All Groups, Weighted Average of Eight Capital Cities, published by the Australian Bureau of Statistics, for the March quarter in year n-1; and

 $CPl_{n-2}$  is the Consumer Price Index, All Groups, Weighted Average of Eight Capital Cities, published by the Australian Bureau of Statistics, for the March quarter in year n-2.

For the year ending 30 June 2019:

- n = 2019;
- n-1=2018;
- n-2=2017;

- $CPI_{n-1}$  is the CPI for the March quarter 2018:  $CPI_{n-1} = 112.6$ ; and
- $CPl_{n-2}$  is the CPI for the March quarter 2017:  $CPl_{n-2} = 110.5$ .

Applying the reference tariff variation formula of the Access Arrangement to the reference tariffs applicable during the year ending 30 June 2018, the varied reference tariffs to apply from 1 July 2018 are those shown in the following table.

Special Contract Transportation Service	\$2.45/GJ	\$2.50/GJ
Contracts Transportation Service	\$3.52/GJ	\$3.59/GJ
Industrial and Commercial Transportation Service	\$7.03/GJ	\$7.16/GJ
Domestic Transportation Service	\$9.14/GJ	\$9.31/GJ
