CENTRAL RANGES PIPELINE GAS NETWORK NOTIFICATION OF ANNUAL TARIFF INCREASE

(For Reference Tariff Effective 1 July 2017 to 30 June 2018)

In accordance with section 3.2, 3.3, 3.4 and 3.4A of the Central Ranges Pipeline (CRP) Gas Network approved Access Arrangement as amended, please be advised that Central Ranges Pipeline Pty Limited intends to vary the CRP Gas Network 2016/17 Reference Tariff as per the tariff escalation method in 3.3:

$$RT_n = RT_{n-1} \times \left(\frac{CPI_{n-1}}{CPI_{n-2}}\right)$$

Where:

means the Consumer Price Index (All Groups - Weighted Average Eight Capital Cities) published quarterly by the Australian Statistician;

CPI_{n-1} means the value of the average of the CPIs for the four quarters to December in Year_{n-1};

CPI_{n-2} means the value of the average of the CPIs for the four quarters to December quarter in Year_{n-2};

As required by the Access Arrangement, the CPI figures used in this correspondence to calculate the average of the CPI for the four quarters to December 2015 and December 2016 are the CPI (All Groups – Weighted Average Eight Capital Cities) as published by the Australian Bureau of Statistics:

CPI Calculation	March	June	September	December	Average
CPI _{n-1}	108.2	108.6	109.4	110.0	109.050
CPI _{n-2}	106.8	107.5	108.0	108.4	107.675

Consequently the CPI escalator is (109.050/107.675) 1.013 (rounded).

This escalator has been applied to the CRP Gas Network Tariffs for 2016/2017 as shown below:

Charges for Ancillary Services
