		APT Facility Management Pty Limited
		APT Facility Management Pty Limited buys and sells gas for the purposes of electricity generation and the operation of natural gas vehicles.
		APT Facility Management Pty Limited buys gas for natural gas vehicles in Western Australia. The gas, once purchased, is compressed and sold as compressed natural gas to bus operators at various bus depots.
		APT Facility Management Pty Limited bought natural gas in Western Australia and has contracted for a storage service at the Mondarra Gas Storage Facility in order to store this gas prior to its eventual resale. While stored in Mondarra, the gas can be used as additional base/cushion gas.
		APA Facilities Management Pty Limited
		APA Facilities Management Pty Limited buys and sells gas for the purpose of supplying liquefied natural gas for vehicles and stationary applications (e.g. replacing diesel for power generation at remote mines) from Dandenong in Victoria. The gas, once purchased, is liquefied by a third party on APA's behalf and then sold by APA Facilities Management Pty Limited as liquefied natural gas to LNG customers who then deliver the product to their end users or re-distribution outlets (e.g. petrol stations). APA Facilities Management Pty Limited holds an exemption from the retail regulations associated with the sale of LNG from the Dandenong facility.

- marketing staff of an associate of APT Petroleum Pipelines Pty Limited (as they may be employees of the associate and could also be within the definition of "officers" of the associate).

None of APT Petroleum Pipelines Pty Limited's marketing staff are officers, employees, consultants, independent contractors or agents or otherwise provide services to associates which take part in a related business.

None of APT Petroleum Pipelines Pty Limited's officers, employees, consultants, independent contractors or agents are marketing staff of an associate that takes part in a related business.



	APA monitors compliance performance, including compliance with confidentiality obligations, quarterly. This monitoring is undertaken by the General Manager Strategy and Regulatory, and relevant commercial personnel associated with the assets. The results are reported to the Board.
	More generally all APA employees are required to comply with the APA Code of Conduct, which explicitly addresses appropriate treatment on confidential and proprietary information, including customer information. Employment agreements also include conditions relating to confidentiality.
	In addition, access to APA computer systems is through individual passwords and user names. Passwords are changed at periodic intervals. Firewall protection is in place to prevent unauthorised access to electronically stored information via the internet.

In relation to post 30 June events we report the following 2 matters relevant to item 3.3(a):

1. On 12 July 2020 (post the current reporting period), an incident occurred in which APA inadvertently sent shipper nomination information, intended for APA commercial operations team, to a shipper. The information included confidential volumetric, but not financial, information.

Once APA became aware of the inadvertent transmission of this information, APA immediately contacted the recipient, who advised that they had not opened the errant email, and undertook to delete it from their system.

While the error in this event related to a non-scheme pipeline data, it potentially disclosed data of an RBP customer.



The key contributing factor to this incident was the increased use of ad hoc email communications between commercial operations staff applied in the current covid-19 work-from-home environment in place of normal systems that assume office co-location.

APA promptly notified the AER and commenced undertaking changes to our email communications systems and protocols to prevent similar incidents occurring in the future.

2. While the above email protocol changes were being designed and implemented, a similar incident occurred on 6 August 2020 (post the current reporting period), in which APA inadvertently sent RBP nomination information relating to one shipper, intended for our commercial operations team, to another shipper. The information included confidential volumetric, but not financial, information.

Once APA became aware of the inadvertent transmission of this information, APA attempted (unsuccessfully) to recall the errant message. The inadvertent recipient advised APA of the error promptly and undertook to delete the email from their system.

APA promptly notified the AER about this incident and the changes being implemented to the APA email system to prevent further occurrences.
