Individual exemption:


The Australian Energy Regulator (AER) decided, on 16 December 2019, to grant Aatlis Utilities Pty Ltd / ACN 629 858 724 an exemption from the requirement to hold a retailer authorisation under section 88 of the National Energy Retail Law, subject to the conditions set out below. This exemption applies to the sale of electricity and gas to business customers within the 'private network' defined as the Aatlis Microgrid, an area including 100 Witmack Road, Wellcamp, Qld, 4350.

Approved Area:

The main power generation will be 100 Witmack Road Wellcamp Qld 4350.

The area covered by the area proposed to sell energy is situated either side of Witmack Road and bounded at the north by the Warrego Highway and the south by Toowoomba – Cecil Plains Road.

The map of the approved area is shown below.



Part 2: Change to Approval:

In accordance with the AER (Retail) Exempt Selling Guideline, (Appendix D: Applicants seeking to vary an individual exemption), we provide the following information:

1. Why Seeking Variation

Aatlis Utilities Pty Ltd makes application to change the area covered in the Individual Exemption.

The change application seeks to change only the distribution area. Everything else in the Individual Exemption remains the same.


We are seeking to change the distribution area in the AER Exemption so it aligns with the distribution area of our Queensland Electricity Act approvals and includes additional proposed customers for our Microgrid.

The location of the power generation plant remains the same.

The changed Area is described as the land either side of Witmack Road bounded in the south by Toowoomba – Cecil Plains Road, to the north by the Queensland Rail - Western Railway Line, to the east by the Toowoomba Bypass (Gore and Warrego Highways) and the western boundary area is bounded by property boundaries of R & D Keeley, Nass Farm Pty Ltd, T & C Theodosis and Leesons Road.

The proposed new distribution area is Industrial and Rural zoned land.

The area of the original distribution area was 1100 hectares and the area of the new distribution area is approximately 2920 hectares.



The enclosed PDF plan with this change application "2019-09-26 Power Map Aatlis Utilities" provides more details of this area.

The map and the power distribution area are the same as that approved under the Queensland Electricity Act "Special Approval" which entitles the approval holder to act as a power distributor.

The proposed change in the distribution area for the Individual Exemption will not change the type of customer. No residential customers are proposed

2. Conditions of Exemption to be varied.

We do not seek to vary any conditions of the Individual Exemption – just the distribution area.

3. Changes to information provided.

Changes to information provided relate principally to the Distribution area. Details of proposed new customers in the extended distribution area have been provided in a confidential copy.
