Report on the limited assurance procedures performed over actual gas volumes reported for the period 1 January 2014 to 31 December 2014 on the proposed 2016 distribution tariff schedule for Australian Gas Networks (Vic) Pty Limited (formerly Vic Gas Distribution Pty Ltd)

Scope

In accordance with the terms of engagement letter dated 27 October 2015, we were engaged by Australian Gas Networks Limited (the "Company") to perform an independent limited assurance engagement in respect of the actual gas volumes reported for the period 1 January 2014 to 31 December 2014 (the "Period") on the attached 2016 proposed distribution tariffs schedule for the Victoria Gas Distribution System ("Vic Gas"). The criteria against which we assessed Vic Gas is Section 4.4.1 of the Vic Gas Access Arrangement for the period 2013 – 2017 (the "Access Arrangement").

Respective responsibilities

The Company is responsible for the preparation of the proposed tariffs schedule for Vic Gas as measured by the Access Arrangement. Our responsibility is to perform limited assurance procedures over the reported actual gas volumes for Period included on the 2016 proposed distribution tariffs schedule for Vic Gas as required by the Access Arrangement.

Our procedures have been conducted in accordance with applicable Standards on Assurance Engagements (ASAE 3000 Assurance Engagements Other Than Audits or Reviews of Historical Financial Information) to provide limited assurance that the Company has prepared the tariffs schedule for Vic Gas in accordance with the Access Arrangement.

Our procedures included:

- agreeing gas volumes for the period reported on the 2016 proposed distribution tariffs schedule to the APA billing system;
- comparing 2014 gas volumes to 2013 gas volumes and obtaining explanations for material variances;
- tracing a sample of invoices for the billing period to the underlying source data that is used to compile the 2016 proposed distribution tariffs schedule; and
- testing mathematical accuracy of the 2016 proposed distribution tariffs schedule.



These procedures have been undertaken to form a conclusion, that nothing has come to our attention that causes us to believe that the reported actual gas volumes for the period 1 January 2014 to 31 December 2014 on the proposed tariffs schedule have not been prepared, in accordance with the Access Arrangement.

Use of report

The compliance review report was prepared for the Directors of Australian Gas Networks Limited in accordance with their requirement to lodge a proposed distribution tariffs schedule for Vic Gas with the Australian Energy Regulator ("AER"). We disclaim any assumption of responsibility for any reliance on this report to any persons or users other than the Directors of Australian Gas Networks Limited, or for any purpose other than that for which it was prepared.

Inherent Limitations

Because of the inherent limitations of any work planned and executed under ASAE 3000, it is possible that fraud, error or non-compliance may occur and not be detected. These procedures are not designed to detect all instances of non-compliance with the preparation of the proposed tariffs schedule for Vic Gas as required by the Access Arrangement, as it generally comprises making enquiries, primarily of the responsible party, and applying analytical and other review procedures. The conclusion expressed in this report has been formed on the above basis.

Conclusion

Based on our completion of limited assurance procedures, which is not an audit, nothing has come to our attention that causes us to believe that the reported actual gas volumes for the period 1 January 2014 to 31 December 2014 on the proposed tariffs schedule have not been prepared, in accordance with Section 4.4.1 of the Access Arrangement for Australian Gas Networks Vic Gas Distribution System for the period 2013 - 2017.
