Re: 2022-23 ELECTRICITY PRICING PROPOSAL SUBMISSION

Please find enclosed the pricing proposal submission for AusNet Electricity Services Pty Ltd (AusNet) electricity network customers for the period from 1 July 2022 to 30 June 2023.

AusNet's tariffs and charges reflect the AER Final Determination and Tariff Structure Statement for AusNet Services' 1 July 2021 – 30 June 2026 regulatory period, which was published on 30th April 2021.

Distribution charges from 1 July 2022 are estimated to increase by an average of 9.8%, while overall network charges (incorporating distribution, transmission and jurisdictional schemes) are expected to increase by an average of 8.2% compared to the 2021-22 financial year.

The change in distribution charges from 1 July 2022 is driven by:

- 2021-22 prices being artificially low as they incorporated handback of \$27m of overrecovered revenue due to COVID lockdowns;
- Adjustment to inflation (\$24m);
- The recovery of costs associated with the June 2021 storms¹ (\$10m);
- Strong reliability performance in the CY2020 and HY2021 resulting in a STPIS reward of \$9m. We have deferred recovery of \$5m of our reward to manage price impacts for our customers.
