Purpose: Full closure of the laneway to facilitate power utility works

Infrastructure and Assets Directorate has reviewed the TMP and offers no objection to the works and associated road and footpath closures subject to compliance with the following:

1. General traffic/pedestrian conditions

- Consultation with all local properties affected by the closure must be undertaken prior to implementation, and the access arrangements of all businesses, construction sites and local residents must be accommodated as required. Local access must be maintained at all times.
- Pedestrians must not be expected to traverse a carriageway to bypass the worksite other than at formal crossing points (i.e. signals, zebra crossings) or under the direct supervision of a traffic controller.

2. Specific conditions related to the TMP

Local Access

Local access and egress for pedestrians and vehicles must be maintained at all times in all streets/laneways.
 Access must also be provided for all local businesses, off street garages and for the servicing of abutting properties, or suitable arrangements must be made with the occupiers.

Pedestrian Access Around Worksite (Partial Footpath Closure)

• All road and footpath closures must be supervised and maintained at all times. A minimum CLEAR 2 metre footpath width should be maintained for pedestrian access past the worksite. Where a footpath width of at least 1.5m cannot be maintained, rather than crossing the street, it is preferred that a pedestrian bypass be provided past the worksite. All temporary on road pedestrian bypasses must have appropriate barriers to protect pedestrians from

live traffic. Appropriate temporary kerb ramps must also be provided to cater for the needs of people with limited mobility. If it is not possible to maintain a 1.5m wide footpath or on-road pedestrian bypass, the applicant must ensure that suitable pedestrian crossing facilities (e.g. pedestrian bypass, signalised crossings, zebra crossings, etc.) are provided around the worksite or have traffic controllers assisting pedestrians traversing a carriageway.

Privately Owned Laneways

 Approval must be received from the relevant property owner for the use of Celestial Avenue, PL5370 for any local traffic detours as Celestial Avenue, PL5370 is/are privately owned (not Council owned).

Failure to comply with any of these conditions will allow the City of Melbourne to take any action it deems appropriate, including:

- · revoking any permits or approvals issued for the project,
- issuing a notice under the Infringement Act 2006 (a fine), and / or
- taking further legal action for compensation for any injuries, damage or loss caused as a result of non-compliance with these conditions.
