Re: Yarra Trams - CitiPower shared assets construction, renewals and maintenance

Keolis Downer is the operator of Yarra Trams on behalf of the Department of Transport as per the MR4 franchise contract which commenced in November 2017 for a seven plus three-year optional extension period. The Infrastructure franchise commitments require us to maintain and renew the physical assets such as substations, tram poles, overhead reticulation, tracks, points, stops, signals, depots and facilities. We are currently in year four of the franchise contract and committed to maintenance and renewals for the remaining quantity of approved infrastructure works. The types of works to be undertaken is condemned pole replacements, upgrading span work, installation of underground feeder cables and pole mounted switch gear installation/renewals.

Works are being undertaken to replace and remove non-compliant installations and assets that are considered end of life as they do not meet standards and legislative obligations. These asset maintenance and renewals works are essential for reliable, safe tram operations and performance of the network.

Yarra Trams has a number of Tram poles which CitiPower shares to support its power distribution assets such as low voltage overhead network and street lighting. Specifically, with the condemned pole replacement program, it requires CitiPower distribution assets to be relocated from the existing condemned poles installations to the newly installed poles to allow for the safe upgrade of the tram corridor infrastructure.

The quantities of condemned poles to be replaced within our franchise contract is 110 condemned poles per annum.

The table below lists the projected and planned works that are to be undertaken from 2020 to 2027 as approved by the Department of Transport, in addition to the condemned poles replacement program.
