

## Consumer Challenge Panel - Member Biographies

### **Ms Louise Benjamin**

Louise has over 20 years' experience in the legal profession, with in-depth knowledge of regulatory decision-making process. She is currently a Regulatory Consultant to Energy Consumers Australia, providing regulatory strategy advice to the CEO and senior executive team. Louise also provides analysis of National Electricity and Gas Law, AER and Tribunal determinations and other regulatory materials to support the ECA's participation in National Energy Market issues.

Louise enjoyed a distinguished legal career, culminating in a promotion to competition law partner at Allens, a regarded international commercial law firm, where she led cutting edge trade practices matters including managing pricing determinations, industry inquiries and protracted and complex access arbitrations. Louise is also an adjunct lecturer at the College of Law.

### **Ms Jo De Silva**

Jo was a member of the inaugural CCP and continues her role in the current iteration. She is a Senior Policy Officer responsible for energy, water and climate policy at the South Australian Council of Social Service (SACOSS). Since commencing this role, Jo has contributed to a number of AER regulatory processes. Jo's previous experience and her role at SACOSS has provided her with good links to a number of consumer organisations, the Essential Services Commission of South Australia (ESCOSA), AEMC, AEMO, government departments, Members of Parliament and their staff.
