Bev Hughson (Chair)	Ms Bev Hughson was a member of the inaugural AER Consumer Challenge Panel (CCP) and continues her role in the current iteration. She has over 30 years of experience in the energy industry, initially working at the Victorian Gas and Fuel Corporation in a variety of management roles in market research, corporate planning, marketing and wholesale market trading. Following gas industry restructuring and privatisation of the Gas and Fuel, Bev transferred to Origin Energy Retail Limited.
	At Origin, Bev had a number of responsibilities including managing the retail regulatory policy and strategy functions during a time of structural change. She was previously the national retail pricing and tariffs manager, responsible for gas and electricity pricing, including negotiating regulated pricing arrangements with state regulators in Victoria, South Australia, Queensland and NSW.
	In 2012, Bev established her own consulting company, Darach Energy Consulting Services, providing advice and support services to consumer organisations on energy related matters including participating on behalf of consumer organisations in the AER's Better Regulation Program and advising consumers on various aspects of the economic regulation of energy networks.

Most notably, this included overseeing the development, negotiation and passage of the Public Administration Act 2004. During this time, Dr Ben-David was also responsible for overseeing and coordinating the state's policy response to emerging concerns about climate change. In 2008, he led the national secretariat for the Garnaut Climate Change Review.

Dr Ben-David has written and presented on a wide range of topics including water reform, energy markets, competition policy, sustainability and economic philosophy.
