re: ElectraNet Transmission Network Revenue Proposal 2024-2028

ElectraNet has today submitted its Revenue Proposal to the Australian Energy Regulatory (AER) for the five-year regulatory control period commencing 1 July 2023.

The Revenue Proposal is the culmination of extensive early engagement with customers and wider stakeholders aimed at developing a well-tested set of proposals that are targeted to customer needs, and capable of both support by customers and acceptance by the AER.

This engagement has shaped the further development of our forecast expenditure programs and the indicative expenditure forecasts included in our July 2021 Preliminary Revenue Proposal, resulting in the following changes from the indicative forecasts:

- a 12% reduction in proposed capital expenditure
- a 3% decrease in proposed operating expenditure
- a smaller increase in real customer prices of 0.8% in 2024 (down from 5% in our July forecast) with a stable outlook thereafter.

We are grateful for customers and stakeholders who have contributed to the development of our Revenue Proposal.

We are also grateful for the commitment of the AER to our early engagement approach and for its active participation in this process. This has provided valuable opportunities for developing shared understanding, responding to feedback on our plans and priorities, and working together towards a better informed and tested Revenue Proposal.

Among the attachments to our Revenue Proposal is a *Customer Engagement Outcomes Report,* which provides an overview of the engagement undertaken and the outcomes of this process. A copy of this report is enclosed for your reference.

Our Consumer Advisory Panel is currently preparing its own report on the outcomes of its engagement on our Revenue Proposal by the end of February 2022, as agreed with the AER. This report will be shared with the AER and CCP members when available.

We look forward to briefing members of the AER Board on our Revenue Proposal at our scheduled meeting on 3 March 2022.
