Variation to the Undertaking to the Australian Energy Regulator given for the purposes of section 59A of the National Electricity Law

1) Background

- a) On 9 July 2018 the Australian Energy Regulator (the AER) accepted an Undertaking given by International Power (Australia) Holdings Pty Limited (IPAH) pursuant to section 59A of the *National Electricity* (South Australia) Law (the Undertaking).
- b) IPAH has requested this Variation to the Undertaking to reflect that some of IPAH's arrangements for the remote control of Synergen plant have changed. Accordingly, certain actions IPAH committed to undertake under paragraphs 29 and 30 of the Undertaking are no longer appropriate.
- c) The Variation will amend paragraphs 29 and 30 of the Undertaking to reflect IPAH's new arrangements for remote control of Synergen plant.
- d) The AER is satisfied that the Variation sought is appropriate in the circumstances.

2) Commencement of this Variation to the Undertaking

a) This Variation comes into effect when the AER accepts the Variation so executed.

3) Variation to the Undertaking

- a) The Undertaking is varied as follows:
 - i) delete the following wording in paragraph 29 (the first Deletion):

During the period of this Undertaking, IPAH undertakes to maintain arrangements such that the PI software, which is used to remotely control the DRYCGT scheduled generating units from PPPS, is installed and maintained on a dedicated computer.

ii) and replace the first Deletion with the following wording:

During the period of this Undertaking, IPAH undertakes to:

- a) maintain the Synergen Remote Control Human Machine Interface (HMI)
 software system, which is used by Pelican Point Power Limited to remotely
 control the DRYCGT scheduled generating units from PPPS, on a dedicated
 computer at the PPPS; and
- b) within nine months of the Commencement Date of this Undertaking, perform testing of the functionality of Synergen Remote Control HMI software system and, if required, make any requisite changes to the software system to ensure its reliable function.
- iii) delete the following wording in paragraph 30 (the second Deletion):

IPAH undertakes, within three months of the Commencement Date of this Undertaking, to document and implement IT escalation procedures to ensure that in the event of a failure of the PI software system, the IPAH IT Support Desk and the responsible IPAH Spot Trader will be notified promptly.

iv) and replace the second Deletion with the following wording:

IPAH undertakes, within nine months of the Commencement Date of this Undertaking, to document and implement IT escalation procedures to ensure that in the event of a failure of the Synergen Remote Control HMI software system, the relevant engineering and management staff, IT Support Desk, and the responsible IPAH Spot Trader will be notified promptly.
