## **Enova Energy Pty Ltd application for electricity retailer authorisation**

I am writing to inform you that the Australian Energy Regulator (AER) has approved Enova Energy Pty Ltd's (Enova ACN 606 176 756) application for an electricity retailer authorisation in accordance with s.92 of the *National Energy Retail Law* (*Retail Law*).

The AER must grant an application for a retailer authorisation if an applicant has satisfied the entry criteria:

- a) the organisational and technical capacity criterion—the applicant must have the necessary organisational and technical capacity to meet the obligations of a retailer;
- the financial resources criterion—the applicant must have resources or access to resources so that it will have the financial viability and financial capacity to meet the obligations of a retailer;
- c) the suitability criterion—the applicant must be a suitable person to hold a retailer authorisation.<sup>1</sup>

On 14 January 2016, the AER considered Enova's application for an electricity retailer authorisation. In making its decision the AER is guided by the objective of the *Retail Law*.<sup>2</sup> The AER's decision is also informed by the assessment approach outlined in the AER's *Retailer authorisation guideline*. The AER has consulted on Enova's application but did not receive any submissions.<sup>3</sup>

The AER considers that Enova has demonstrated its capacity and suitability to operate as an energy retailer under the *Retail Law*. Enova is therefore authorised to sell electricity under the *Retail Law*, as it is adopted in each participating jurisdiction.

Please note that this letter constitutes the AER issuing Enova's electricity retailer authorisation under s. 96 of the *Retail Law*. Enova's electricity retailer authorisation identification number is **E16001**.

The AER will publish a notice about Enova's retailer authorisation on its website,<sup>4</sup> and Enova's details will also appear on the AER's public register of authorised retailers (on the AER's website).<sup>5</sup>
