JEMENA ELECTRICITY NETWORKS (VIC) LTD HY2021 FINAL PRICING PROPOSAL

In accordance with the timetable and instructions set by the Australian Energy Regulator (**AER**), Jemena Electricity Networks VIC Ltd (**JEN**) is pleased to submit its final pricing proposal for the six-month period from 1 January 2021 to 30 June 2021 (**HY2021**) for approval. The pricing proposal covers distribution, transmission, jurisdictional scheme, alternative control and public lighting tariffs for HY2021.

This letter and accompanying documents constitute JEN's HY2021 final pricing proposal.

The final HY2021 pricing proposal is submitted with the following amendments as required by the AER:

- JEN has updated our pricing proposal and tariff schedule to be clear that those prices described in dollars per annum will be applied on a pro-rata basis for the 6 month period.
- JEN has reverted the rounding of unmetered supply back to 4 decimal places as per the AER's template.
- JEN has updated the total annual revenue requirement in the tariff model to reflect the AER's Final Decision on JEN's annual revenue for the 6 month period. We have not subsequently adjusted prices.

JEN's HY2021 final pricing proposal submission therefore requires the following adjustments:

1. JEN's HY2021 final pricing proposal (*Public*):
 - a. Note to be clear the per annum prices will be pro-rated in section 1.2.
 - b. Allowed revenue updated in section 4.1.
 - c. Appendices updated to be clear the per annum prices will be pro-rated.

2. JEN's HY2021 final pricing proposal Attachment 1- (*Confidential*):
 - a. Revenue updated in cell C10 of the "2021DistRevRevCapForm" tab.
 - b. Adjusted rounding of the unmetered supply price in cell I7 of the "Unmetered supply" tab.
3. JEN's HY2021 final pricing proposal Attachment 1- (*Public*) – adjustments consistent with the confidential version.
4. JEN's HY2021 final pricing proposal Attachment 2 – Tariff Schedule (*Public*) – adjusted at various points to highlight annual charges will be charged on a pro-rated basis.

JEN notes the HY2021 Pricing Proposal Confidentiality statement Attachment 3 of the draft pricing proposal is taken to be a part of the final pricing proposal.
