Revisions to the GasNet System access arrangement

On 24 August 2004, GasNet Australia (Operations) Pty Ltd (GasNet) lodged, for approval by the ACCC under the provisions of the *National Third Party Access Code for Natural Gas Pipeline Systems*, proposed revisions to the access arrangement covering the GasNet System in Victoria

The access arrangement describes the terms and conditions under which GasNet offers third party access to the GasNet System. The ACCC approved the access arrangement for the GasNet System in 1998 and revised the access arrangement in 2003. (This was later varied by the Australian Competition Tribunal.) The next scheduled review of the access arrangement is due in 2007 and the current proposed revisions are voluntary.

GasNet proposes to change four specific aspects of its access arrangement only:

- the price control formula, so that the over-recovery of the maximum average revenue in any year is returned to users over the remainder of the access arrangement period rather than all in the year following the over-recovery;
- the transmission refill tariff applicable to injections into the Iona underground storage facility, so that gas injected into the facility and then withdrawn into the SEA Gas pipeline will pay the same tariff as if it were withdrawn directly from the GasNet System into the SEA Gas pipeline;
- the forecast volumes (on which tariffs are based), in light of the new weather standard adopted by VENCorp in November 2003. GasNet does not propose to incorporate any other changes VENCorp has made to its forecasts since the ACCC's assessment of GasNet's access arrangement in 2002; and
- the rules governing the alterations to tariffs, so that if the ACCC approves these revisions after it has made a decision on the annual tariff adjustment (which must be submitted by mid November), the tariff adjustment may be resubmitted, based on the revised access arrangement.

Interested parties are invited to make submissions to the ACCC on any issues relevant to these proposed revisions by 30 September 2004. The ACCC prefers that all written submissions be publicly available to foster an informed, transparent and robust consultative process. Accordingly, submissions will be treated as public documents unless otherwise requested. Parties wishing to submit confidential information are asked to provide both confidential and non-confidential versions of their submission. All non-confidential submissions will be placed on the ACCC's website. Any information for which confidentiality is claimed will be dealt with under sections 7.11-7.13 of the code.
