# Introduction

Future X is a specialised electricity retailer and energy service provider, specialising in renewable energy. With our head office in Brisbane, we are rapidly expanding to all major capital cities across Australia and as such are looking to diversify our energy retail offerings.

Future X's mission is to install and maintain renewable energy systems through Power Purchase Agreements (PPAs), allowing our customers to pay no upfront costs. We take pride in ensuring our customers are able to access renewable energy in a way that reduces financial burden installing a system can induce.

Future X offers Power Purchase Agreements (PPAs), which is a contract agreement between Future X, who is the provider of the solar system, and the customer. Future X pays all the upfront costs for the solar system, including its installation and any maintenance, and for the term of the PPA, owns the system. The customer purchases the electricity that is generated by the solar system from Future X at an affordable rate for the term of the PPA. At the end of the PPA term, the customer, has the option to purchase the system from Future X, for as little as \$1.

Future X is also an energy retailer providing grid energy to its PPA customers. Future X's strategic direction is to expand solutions to existing customers while offering a range of products to new customers. Whilst a gas retailer authorisation will enable us to sell gas to customers outside of the PPA model and to new retail customers, renewable energy through PPAs will still remain our core business operation.


