## Powerlink Transmission Network Forum Participant Feedback Report






To rate the effectiveness of the Powerlink Transmission Network Forum and identify areas for future improvement, participants were asked to complete a feedback form. Of the approximately 80 participants, 58 completed and returned feedback forms.

Participants were asked to rate on a scale of 1 to 5 (1 being not very useful to 5 highly useful) the information presented at the forum and in the individual breakout sessions. The results are shown below:







Participants were also asked to provide any other specific feedback they had on the forum. The below shows the responses received:

Enjoyed the new theme. Breakout sessions very useful

Great info (perhaps pre-reading) on the management decision frameworks Powerlink operate with (e.g. Risk appetite statements/business casing frameworks and methodologies)

I thought it was a very good change to the usual TAPR - well done Powerlink

Improvement over last year. Breakout sessions good way to improve understanding and gain stakeholder input.

Network optimisation discussion should take place with customer groups on a geographic basis. What is achieved in Brisbane CBD is different in central Qld.

Good format. Enabled networking with other attendees.

Perhaps a tighter focus on issues

Wouldn't change anything. Continue your natural leadership in this realm

The breakout sessions and dinner table settings were an excellent approach to enable genuine discussion and stakeholder engagement.
