AMENDMENT OF VENCORP'S REVISED ACCESS ARRANGEMENT

The Commission, on 14 August, issued a Draft Decision ('**Draft Decision**') on the Revised Access Arrangement for the Principal Transmission System lodged by VENCORP on 28 March 2002.

VENCORP accepts the amendments proposed by the Commission in its Draft Decision.

Accordingly, we have amended our Revised Access Arrangement and the associated Revised Access Arrangement Information. This submission lodges these amendments with the Commission.

The Draft Decision approves the Reference Tariff Policy and associated pricing controls proposed by VENCORP in its Revised Access Arrangement. The Draft Decision did not explicitly require the consequential changes to the MSO Rules to necessary implement this policy, as described and provided in our covering letter to our 28 March submission. Nevertheless, it is implicit in the Draft Decision by the Commission on our proposed Reference Tariff Policy that these consequential changes to the MSO Rules should be made.

Accordingly, we have incorporated these changes to the MSO Rules which are part of the Revised Access Arrangement (as Appendix 5 to the Revised Access Arrangement).

Attached are the following documents forming the submission to the Commission:

- the Revised Access Arrangement amended in accordance with the Draft Decision
- a complete set of the associated Appendices (some unchanged from the 28 March lodgement):
 - Appendix 1 (Description of the PTS), Appendix 3 & 4 (Rebalancing control mechanisms) - each unchanged from the 28 March submission
 - Appendix 2 (Pro-forma Gas Transportation Deed) – with one erratum corrected: mailing address of VENCORP corrected to current postal address
 - Appendix 5 (MSO Rules) – replacing the 28 March version (version 16 of the MSO Rules) with MSO Rules based on the current version 18, including the previously noted changes for FRC which have been approved by the Commission (assumed to be in force as of 2003), and incorporating the changes as noted in our covering letter to the 28 March submission.

- A listing of all changes made by this submission to documents of the 28 March submission.
