PNG Gas Project - application for authorisation A40081 – entry of AGL

We refer to our telephone conversation of 14 February 2006 and confirm we act for the parties listed in Annexure 1 to the application for authorisation dated 14 December 2004 (**Applicants**).

On 17 February 2006, AGL Gas Developments (PNG) Pty Limited ABN 37 001 389 939 (**AGL**), completed its purchase of interests in PNG Petroleum Development Licences PDL1 and PDL4 from companies in the Oil Search Limited Group and entered into various conditional agreements with the Applicants, pursuant to which AGL will enter as a participant in the PNG Gas Project joint venture

As a result, the Applicants hereby notify the Australian Competition and Consumer Commission (**Commission**) of consequential amendments that they wish to make in relation to their authorisation application (A40081) and the Interim Authorisation (A40081) of 13 October 2000 concerning joint marketing arrangements for PNG Gas

The Applicants hereby:

- (a) notify the Commission that they wish to amend their authorisation application (A40081) to add AGL as an applicant to the application. The Applicants request that the Form B notice submitted to the Commission on 14 December 2004 be treated as being varied by:
 - (i) the addition of AGL to section 1(a); and
 - (ii) the addition of the following address details in Annexure 1:
